- For official Federation international representative matches, tours, and leagues, the Catalan Cricket Federation (FCC) assumes responsibility for organizing, supervising, and managing all official travel, accommodation, practice sessions, and official squad itineraries.
- I authorize travel within or outside of Spain (air, sea, bus, train, or private vehicular transport) according to the responsible entity outlined above.
- The minor must comply with all Code of Conduct requirements, safety protocols, and directives issued by designated chaperones, coaches, and officials

## 5. DATA PROTECTION & JOINT IMAGE RIGHTS (GDPR / LOPDGDD COMPLIANCE)

I hereby grant EQUAL AND JOINT AUTHORISATION to both the participating Club and the Catalan Cricket Federation to capture photographs, video, and audio recordings of the minor during the event. Both entities are authorized to use such media for official promotional material, websites, social media channels, sports news reporting, rebranding, and publications.

## 6. SAFEGUARDING & CHILD PROTECTION DECLARATION (LOPIVI & ICC COMPLIANCE)

Pursuant to Organic Law 8/2021 (LOPIVI) and ICC Safeguarding Regulations:

- For domestic activities, the Club retains primary duty-of-care safeguarding compliance.
- All adult personnel, coaches, and managers accompanying or supervising minors must hold valid background check clearances confirming no record of sexual offenses or violence against minors.
- Any safeguarding concern, breach of conduct, or safety issue must be reported directly to the designated Club and the FCC.

## 7. INSURANCE & DIVISION OF LIABILITY RESPONSIBILITY

### a. DOMESTIC COMPETITIONS & EVENTS:

- **FEDERATION BASIC COVERAGE:** Pursuant to Catalan Sports Legislation (Decret Legislatiu 1/2000), the Catalan Cricket Federation (FCC) provides basic mandatory sports accident insurance (Segur d'Accidents Esportius) for registered players, limited strictly to covered injuries occurring DURING OFFICIAL DOMESTIC MATCH PLAY within the scheduled match fixture.
- **CLUB LIABILITY:** All non-match activities—including training sessions, team practice, local/domestic transport, independent travel, accommodation supervision, and off-pitch organization—are the SOLE RESPONSIBILITY AND LIABILITY of the participating Club and its designated Coaches, Managers, and Staff. Basic FCC insurance DOES NOT COVER travel accidents or activities outside official domestic match hours.

### b. INTERNATIONAL LEAGUES & SELECTION CATALAN COMPETITIONS:

- For sanctioned international tours and official Catalan team representative competitions, the Catalan Cricket Federation (FCC) assumes operational control and primary responsibility for official team travel, official practice sessions, scheduled matches, and team logistics.
