7. FCC NO-OBJECTION CERTIFICATE (NOC) & TRANSFER RULE

- Any player registered with the Catalan Cricket Federation (FCC) wishing to participate in, play for, or represent any non-affiliated cricket organization, team, private league, or international event must obtain a formal FCC No-Objection Certificate (NOC) prior to participation.
- Procedure: The inviting entity or player must submit an official NOC request to the FCC administration. Participation is strictly prohibited until the written NOC is granted.
- Disciplinary Sanctions: Non-compliance with the NOC procedure constitutes a regulatory infraction under FCC Disciplinary Rules. Breaches may result in disciplinary action, including suspension or bans ranging from 1 to 2 years, following a hearing procedure.

8. ALLOCATION OF RESPONSIBILITIES & LIMITATION OF LIABILITY

FEDERATION RESPONSIBILITY & LIABILITY LIMIT (FCC):

- The FCC acts solely as the regulatory, sanctioning, and governing body for cricket in Catalunya.
- FCC liability is limited strictly to structural event organization, regulatory oversight, and maintaining mandatory basic sports insurance coverage DURING OFFICIAL MATCH PLAY of scheduled match fixture within the bounds of applicable legislation. Neither the FCC nor its official shall be held liable for personal injuries, property damage, or third-party acts arising from independent activities, unauthorized travel, off pitch activities or player negligence.
